A brief history of the Cork City JPC

"Joint policing committees will provide arenas where the Garda Síochána and local authorities can co-operate and work together to address local policing and other issues.¹"

The statutory basis for the establishment of Joint Policing Committees (JPCs) is set out in section 35 of the An Garda Síochána Act 2005. It provides for the establishment of and sets out membership of the committees to be made up of councillors, An Garda Síochána, Oireachtas members and community representatives.

The functions of Joint Policing Committees are set out in the Act. Section 36(2) states that... *"the joint policing committee's function is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of the local authority's administrative area, and in particular to -*

(a) keep under review—

(i) the levels and patterns of crime, disorder and antisocial behaviour in that area (including the patterns and levels of misuse of alcohol and drugs), and (ii) the factors underlying and contributing to the levels of crime, disorder and anti-social behaviour in the area,

- (b) advise the local authority concerned and the Garda Síochána on how they might best perform their functions having regard to the need to do everything feasible to improve the safety and quality of life and to prevent crime, disorder and antisocial behaviour within the area,
- (c) arrange and host public meetings concerning matters affecting the policing of the local authority's administrative area,
- (d) establish, in consultation with the local Garda superintendent, as the committee considers necessary within specific neighbourhoods of the area, local policing fora to discuss and make recommendations to the committee concerning matters that it is to keep under review under paragraph (a) or on which it is to advise under paragraph (b), in so far as those matters affect their neighbourhoods, and
- (e) co-ordinate the activities of local policing fora established under paragraph (d) or otherwise."

Responsibility for the Joint Policing Committees nationally rests between the Department of Justice and the Department of the Environment and Local Government. The Local Policing Authority recently established now has general powers relating to the establishment and maintenance of joint policing committees.

In 2007 the then Minister for Justice, Equality and Law Reform, Mr. Michael McDowell consulted with the then Minister for the Environment, Heritage and Local Government, Mr. Dick Roche, to develop JPC guidelines.

The first meeting of the Cork City JPC was held in the Council Chamber, City Hall, Cork on the 19th November 2007, as part of a national pilot project.

The first Cork committee consisted of twenty seven members – 16 local authority elected members, 6 members of the Oireachtas, 2 members of An Garda Síochána and 3 persons representing the community and voluntary fora. Additionally, the Lord Mayor and the City manager were ex-officio members.

Local Policing Fora (LPF):

The statutory basis for the formation of Local Policing Fora is set out in section 36(2) (d) of the Garda Síochána Act 2005. The JPC must

- (d) establish, in consultation with the local Garda superintendent, as the committee considers necessary within specific neighbourhoods of the area, local policing fora to discuss and make recommendations to the committee concerning matters that it is to keep under review under paragraph (a) or on which it is to advise under paragraph (b), in so far as those matters affect their neighbourhoods, and
- (e) co-ordinate the activities of local policing fora established under paragraph (d) or otherwise."

The fora provide a mechanism through which the community, Gardaí and Cork City Council can come together in a formal structured way with the community to consider issues of community safety.

Community Safety Fora (CSF)

In 2006, the National Monitoring Committee, in consultation with An Garda Síochána, identified community safety as a key priority, following which Community Safety Fora were established in the four Cork City RAPID areas in 2007:

- Togher & Mahon,
- Knocknaheeny, Hollyhill & Churchfield
- Blackpool, the Glen & Mayfield and
- Farranree, Fairhill & Gurranabraher.

Members of the public can raise issues of concern with respect to community safety, additionally; a structure is in place to ensure an appropriate response is received. These meetings are held three times a year.

These fora have received significant support from An Garda Síochána and the City Council and a number of achievements can be identified, namely:

- The creation of family friendly bonfire nights to overcome antisocial behaviour on bonfire night.
- Installation of fixed and mobile CCTV in anti-social behaviour hotspots.
- Establishment of the community warden service.

- Graffiti removal initiatives were undertaken
- Greater interagency cooperation has been achieved in relation to alcohol and drugs in the north west of the city.
- Youth cafes and late night soccer games were also arranged.

The terms Local Policing Fora (LPF) and Community Safety Fora (CSF) are used interchangeably in Cork.

Local policing fora are now established per Garda Divisional structures

- Anglesea Street
- Gurranabraher
- Mayfield and
- Togher.

Neighbourhood Watch groups still in existence are also represented on the citywide structures. New community safety fora are being developed to allow people to get as close to local communities as possible.

Local Policing Fora Management Committees (LPFMC)

A management committee in each Garda district oversees the work of the local policing fora in its district (including community safety fora and neighbourhood watch). The composition includes elected JPC members (i.e. Councillors and Oireachtas members) and community JPC representatives, chairs of the local policing fora and representation from the local alcohol and drugs task force committee.

Matters arising at the LPF meetings that cannot be resolved locally are referred to the management committee and issues that cannot be resolved by the management committee are referred to the JPC for resolution.

Revised guidelines

In August 2014, the Minister for Justice and Equality in consultation with the Minister for the Environment, Community and Local Government, issued revised guidelines for the operation of each JPC, following a review carried out in 2012.

Important changes noted in the Preface to the Amended Guidelines include:

- The requirement for Committees to develop a six year and annual strategic plans and to report on their implementation in Annual Plans
- The number of community representatives was increased and
- The need for a proper communications strategy to support interaction with local communities and effective and

efficient coordination with other local structure.

The revised guidelines increased the number of members on the Cork City JPC by six to thirty three members –

- 16 local authority elected members,
- 6 members of the Oireachtas,
- 2 members of An Garda Síochána,
- 7 Community representatives
- 2 local authority officials. The Chief Executive, being an ex-officio member and one other nominated by the Chief Executive.

Policing Authority and the JPC

The Policing Authority has been established under the Garda Síochána (Policing Authority and Miscellaneous Provisions) Act 2015 and confers on the Authority general powers relating to the establishment and maintenance of joint policing committees by local authorities and the Garda Commissioner, which had previously been held by the Department of Justice and Equality.

It provides that the Authority shall issue from time to time guidelines for the operation of JPCs. Current guidelines remain in place until such time as they are amended. In addition, the Authority may convene meetings of the chairpersons and such other persons as the Authority considers appropriate, of JPCs for the purposes of coordinating, or otherwise facilitating, the performance of the functions assigned to them. The first such meeting will take place on 13 July 2016.

As an example of a bottom up approach, the JPC will be invited from time to time to make submissions to the Policing Authority, including for example in relation to the development of policing priorities."

Six Year Strategic Plan

Cork City JPC is tasked with developing a six year community plan which will be delivered through annual work plans and which must include relevant objectives from the Garda annual policing plans applying in the City.

The Chair Cllr. Chris O'Leary advised a public meeting on 18th May 2015 that it was his intention to oversee the development of six year strategy for the JPC.

The intention to identify strategic priorities and will address the following areas:

- Crime Prevention
- Anti-social behaviour and street crime

- Misuse of drugs and related crime
- Support for crime victims

At its meeting of 7th September 2015 the Joint Policing Committee Steering Committee agreed to commence the process of developing the strategy. The JPC meeting of 21st September was informed that a public consultation process would be embarked upon to inform the development of the strategy.

Consultation to inform the strategy

A public consultation process was undertaken by way of a public call for submissions.

Local policing fora were invited to consider what might be included in the six year strategy at their meetings and submissions were made on their behalf.

All submissions received from the public generally and the local policing fora were reviewed an draft objectives collated by a sub group comprising representatives of An Garda Síochána, City Council and the Public Participation Network (PPN).

Cork City Council and Oireachtas members considered the draft objectives at a specially convened meeting and the draft objectives also considered at a plenary meeting of the Public Participation Network (PPN).

At its meeting of 15th February 2016 the JPC referred an amended draft for consideration to the local policing fora management committees. At its meeting of 3rd May 2016 the Joint Policing Committee agreed the final draft of the JPC Six Year Strategy subject to amendments noted at the meeting.

Implementation of the Strategy

Strategic Aims

The strategic aims outlined below will be prioritised by the JPC Steering Group and annual plans will be developed with the JPC membership for the implementation of the different aspects of the strategy.

A system of periodic reporting and overview of the delivery of the annual plans by the JPC membership will be developed to drive the strategy forward.

Appendix 2

JPC Work Plans

Each JPC must make strategic work plans which link with other appropriate plans and strategies. In this regard each JPC must put in place

A six year plan linked to the relevant objectives in the Local Economic and Community (LCD) Plan of the local authority

An Annual Work Plan which, as well as linking to the LCD Plan, must include relevant objectives from the Garda Annual Policing Plan(s) applying to the local authority area.

JPC plans should be confined to a limited number of strategic objectives to facilitate appropriate monitoring and review.

JPCs plans should focus on areas where cooperative and collaborative actions can add most value to the existing work of relevant stakeholders. It is important that plans set specific and measurable objectives, identify lead individuals or agencies as well as others responsible for contributing to relevant actions, include relevant resource allocation and set out defined timescales. In addition to including key objectives derived from the LCD and Annual Policing Plans as set out above, consideration should be given to linking JPC plans to

Appropriate elements of other local authority or Garda strategies (e.g. accommodation plans or particular crime prevention initiatives)

Drugs Task Force Plans relevant to the area

Other issues which the JPC considers to be important for crime prevention, policing and public safety (including road safety) in the area

Strategic actions to enhance communications with the public and to ensure adequate communication with other local fora (e.g. Drugs Task Forces, local policing fora, Community Alert and Neighbourhood Watch, Groups, and other relevant local fora) to prevent duplication and support coordinated action

Annual work plans should include consideration of how JPCs can enhance overall efforts to address key issues affecting community life, including

Crime Prevention

Anti-social behaviour and street crime

Misuse of drugs and related crime

Support for crime victims, including those affected by domestic violence

In addition, work plans must prioritise objectives and highlight at least three strategic priorities. Templates for the JPC six year and annual work plans have been devised and it is hoped that these will assist committees in their work. JPCs should use the templates provided but are free to include other relevant information in their plans if they so wish.
