Cork City PPN is funded by the Department of Rural and Community Development (DRCD) and by Cork City Council (CCC).

- DRCD will provide €85,700 in core funding from the Department in 2024
 - Core Funding: €60,000
 - Ring-fenced support worker funding: €25,700
- CCC will provide €35,000 in funding for 2024
 - Core funding: €30,000
 - Support worker funding: €5,000

This funding is used for the purpose of developing and maintaining the PPN. The most common usage of which the Department envisages the funding would be:

- Staff salaries
- Expenses incurred by the PPN in carrying out its activities hosting meetings and events, training workshops, promotional material, etc.
- Hosting fee for the PPN
- Expenses of the secretariat and PPN reps.
